## **Register of Governor Interests**

From September 2015, governing bodies are under a duty to publish their register of interests on the school website. A template is attached at Appendix 2. It is important to address any perception of a conflict of interest by making clear where such potential personal or pecuniary interests might apply.

#### Governors must declare:

- Any relevant business interests financial, or other, and interests in an organisation that would feasibly be in a position to supply goods/services to the school
- Details of any other educational establishments they govern
- Any relationships between governors, pupils and members of the school staff including spouses, children, partners and relatives.

## **Examples (potential conflicts):**

- A governor whose spouse/partner is employed by the school Should not take part in discussion regarding the school's pay policy or any staffing matter that might impact on their partner.
- A governor on the management committee of a childcare provider or after school club who rent part of the school – Should not be party to discussion involving the use of the school or their lettings/charging policy.
- A governor who is a supplier of goods or services to the school Should not take part in decisions regarding the letting of contracts for that type of goods or services or where a sub-contract relationship might exist.
- If in doubt, declare!
